### WHAT STEPS DO I TAKE TO BECOME A COLORWASH FRANCHISEE?

1. Thank you for your interest in the **COLORWASH** Franchise.
2. Please complete the confidential **Franchise Application Form** and send a soft copy to [admin@colorwash.com.sg](mailto:admin@colorwash.com.sg) or by mail to 333A Orchard Road, Mandarin Gallery, #03-05 Singapore 238867.
3. We will either conduct a telephone interview with you or meet you personally in an attempt to discover first, if this is something you are able to do and second, if we feel that you will make a successful area, master or unit franchise owner. If we feel that you are suitably qualified for this franchise business endeavour, we will inform you accordingly.
4. At this moment in time, you are required to complete the registration process by depositing **non-refundable Application Fee of SGD Dollars SGD\$2,000. However this fee will in included in the upfront fee should you be successful in your appointment as a COLORWASH Franchisee and subsequent payment of the upfront fee.**
